Dr Carson is in charge of dermatology education for the Family Practice physicians at San Jose O`Conner Hospital. Dr. Carson has been in private practice in San Jose since 1980, he is thrilled to become a member of CSI because of the shared goal of high quality of care and offering the most up-to-date technologies and techniques.

Dr. Ball is a board certified dermatologist and fellowship-trained Mohs and laser surgeon specializing in a variety of procedures including Mohs micrographic surgery, advanced reconstructive techniques, cosmetic procedures and laser surgery. She completed her dermatology residency at Stanford University and subsequently obtained board certification. Before joining California Skin Institute, Dr. Ball completed additional training in Mohs surgery and procedural dermatology during a prestigious fellowship at the University of California, Irvine.

The new South San Jose location is a continuation of California Skin Institute's growth across Northern California. This new center will be California Skin Institute's fifteenth physical location, and nineteenth practice merger.
